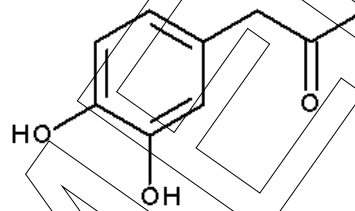

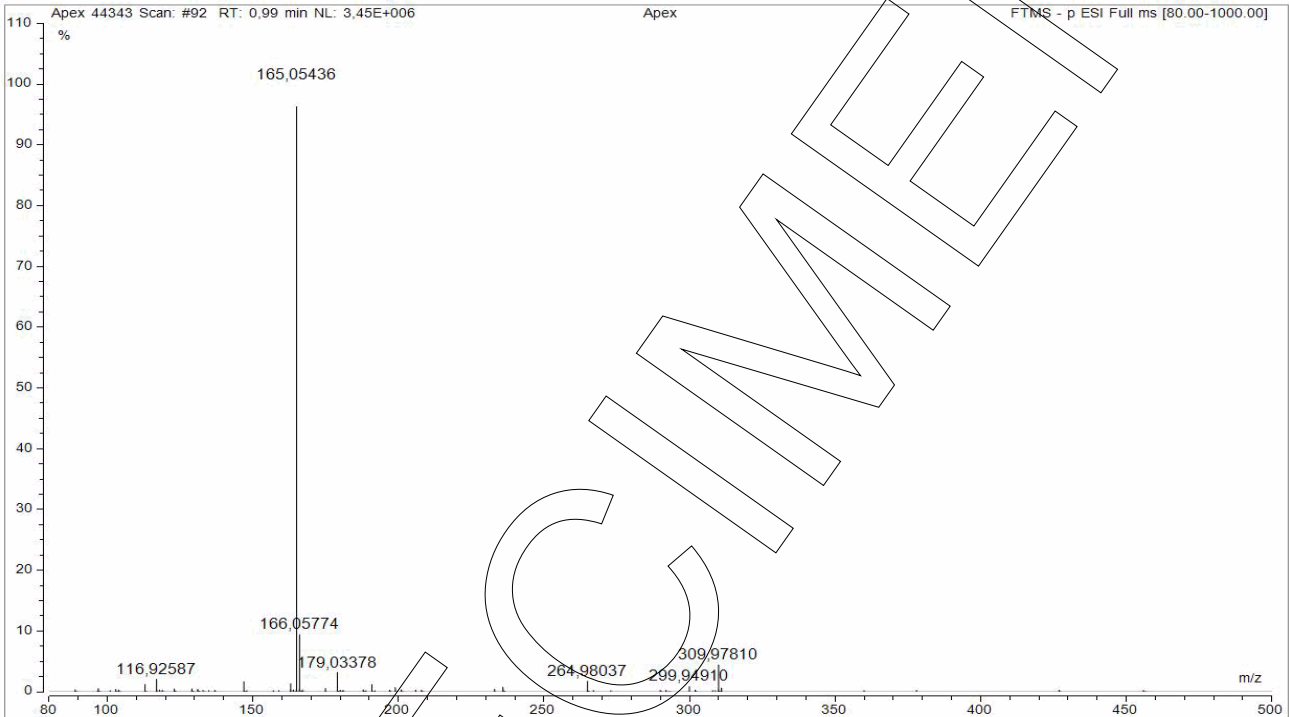

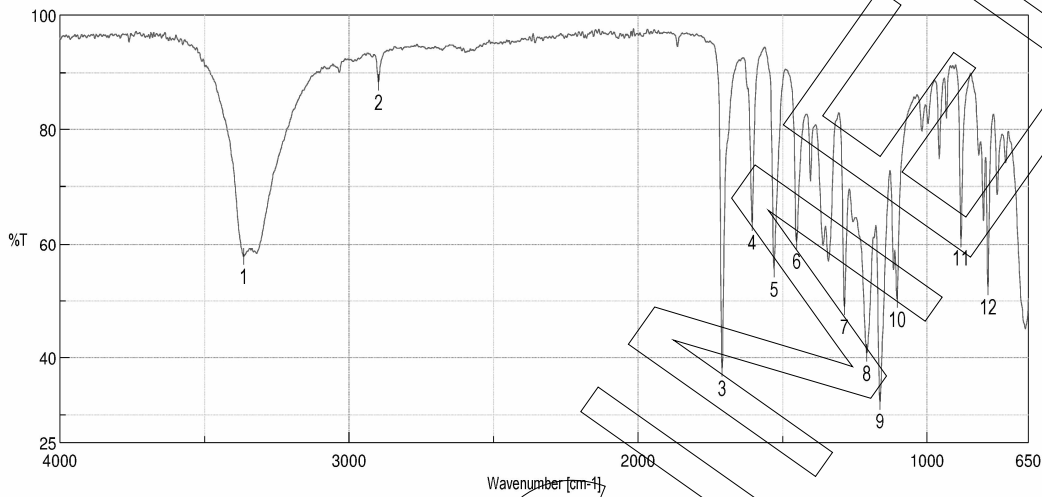

## Assay

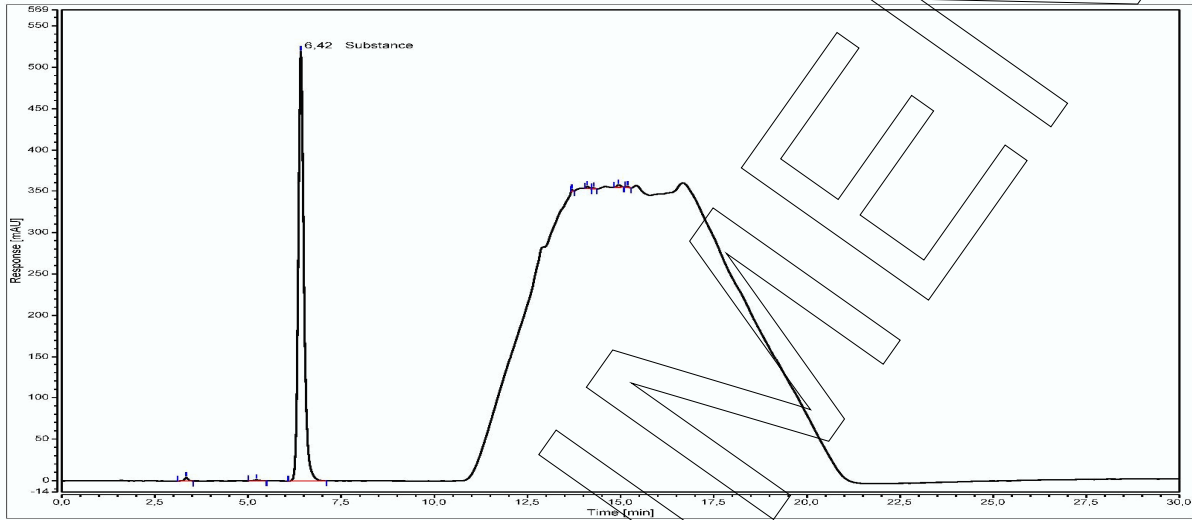
The assay of the reference material was assessed by following analyses.

### Purity by High Performance Liquid Chromatography (HPLC)

HPLC Conditions:	
Column	Hypersil Gold C18; 5 µm, 150 x 4.6 mm
Column temperature	40 °C
Detector	DAD, 196 nm
Injector	Auto 1 µl; 0.082 mg/ml in Water
Flow rate	1.0 ml/min
Phase A	Water, 0.1 % H <sub>3</sub> PO <sub>4</sub>
Phase B	Acetonitrile, 0.1 % H <sub>3</sub> PO <sub>4</sub>
Gradient program	0-8 min A/B 90/10 8-11 min A/B to 50/50 11-14 min A/B 50/50 14-18 min A/B to 90/10 18-30 min A/B 90/10 (v/v)

The content of the analyte was determined as ratio of the peak area of the analyte and the cumulative areas of the purities, added up to 100 %. System peaks were ignored in calculation.

**Result (n = 3)** 98.26 %; SD = 0.21 %

## Final result

**Assay "as is": 96.94 %**

The assay "as is" is assessed by 100% method (mass balance) and is equivalent to the assay based on the not anhydrous and not dried substance respectively.

The calculation of the 100% method follows the formula:

$$\text{Assay (\%)} = (100 \% - \text{volatile contents (\%)}) * \frac{\text{Purity (\%)}}{100 \%}$$

Volatile contents are considered as absolute contributions and purity is considered as relative contribution. Inorganic residues are excluded by additional tests.
