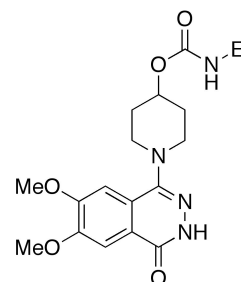

Appropriate Engineering Controls

A laboratory fumehood or other appropriate form of local exhaust ventilation should be used to avoid exposure.

Personal Protective Equipment

Eye/Face Protection

Skin Protection

Gloves should be used when handling this material. Gloves are to be inspected prior to use. Gloves used for incidental exposures (splash protection) should be designated as “chemical resistant” by EU standard EN 374 with the resistance codes corresponding to the anticipated use of the material. Unrated gloves are not recommended.

Suggested gloves: AnsellPro Sol-Vex nitrile gloves style 37-175, 15 mil thickness.
