

8.1 Control Parameters

Appropriate Engineering Controls

A laboratory fumehood or other appropriate form of local exhaust ventilation should be used to avoid exposure.

Personal Protective Equipment

Eye/Face Protection

Skin Protection

Unrated gloves are not recommended. Suggested gloves: AnsellPro Sol-Vex nitrile gloves style 37-175, 15 mil thickness.
