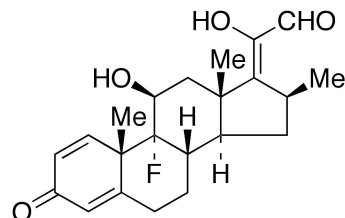

### **Appropriate Engineering Controls**
