
I. Identity

The structure is confirmed with the signals of the spectrum and their interpretation.





II. Purity

The purity of the reference substance was analysed by high performance liquid chromatography (HPLC).

HPLC Conditions:

Column: RP 60 Select B 5 µm, 125 x 4 mm, Conditions: 1.0 ml/min, 40 °C 0-8 min Water/Acetonitrile 80/20 8-15 min Water/Acetonitrile to 60/40 15-20 min Water/Acetonitrile 60/40 20-25 min Water/Acetonitrile to 80/20 25-35 min Water/Acetonitrile 80/20 (v/v); 0.1 % H₃PO₄



Water (KF) and Residual solvents (RES) are considered as absolute contributions, HPLC purity is considered as relative contribution.
