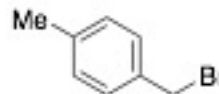

#### General Advice

#### Appropriate Engineering Controls

A laboratory fumehood or other appropriate form of local exhaust ventilation should be used to avoid exposure.

#### Personal Protective Equipment
